SECTION 1: GENERAL INFORMATION

1.1 INTRODUCTION

This Request for Information (RFI) is issued by Oregon State Hospital (OSH) with locations in Salem and Junction City, Oregon, to gather information regarding potential vendors to supply food and non-food products for resale in the OSH Patient Market (Commissary). The purpose of this RFI is to understand the capabilities, offerings, and experience of potential vendors in this area, and to inform future procurement decisions. This RFI does not constitute a commitment to award a contract, nor does it obligate your organization to any future action.

1.2 BACKGROUND

Oregon State Hospital (OSH) is an essential part of the statewide behavioral health system, providing the highest level of psychiatric care for adults from all 36 counties in Oregon. OSH operates two campuses with a total of 742 licensed beds, with 592 beds in Salem and 150 beds in Junction City. OSH services are provided 24 hours per day, seven days a week. The hospital's primary goal is to help people recover from their mental illness and return to life in the community.

1.3 REQUEST FOR INFORMATION PURPOSE

OHA has initiated this RFI to gather information from prospective vendors who stock commissaries in institutional settings. Participation in this RFI will assist the Oregon State Hospital in creating a Request for Proposal (RFP) which will provide more detailed scope of work that aligns with Patient Market (Commissary) needs and successful outcomes from other state efforts.

1.4 WHO MAY RESPOND?

OHA is seeking information from Respondents who have demonstrated experience in providing goods similar in nature to a commissary in a correctional facility.

1.5 PROJECT OVERVIEW

Oregon State Hospital would like to secure a vendor(s) to supply goods for its Patient Market (Commissary). The Patient Market is similar in nature to a commissary in a correctional facility, where residents of the facility can buy goods using their own money. Oregon State Hospital is not a correctional facility; however there are similar restrictions on contraband and must ensure that products sold in the market are safe. Products must eliminate (or at least minimize) the risk of ligature or being fashioned into a weapon. OSH is seeking to purchase items in bulk, then distribute these items through the patient markets located on each campus. Prior to bulk orders, OSH must review each prospective item for a product risk assessment to determine potential risk to patients.

1.6 DUE DATE

Responses to this RFI will be received until the Opening date and time as referenced on the cover page of this RFI. Responses received after the Opening date and time shall be deemed late and will not be considered.

1.7 SINGLE POINT OF CONTACT (SPC)

The SPC for this RFI is identified on the Cover Page, along with the SPC's contact information. Respondent shall direct all communications related to any provision of the RFI only to the SPC, whether about the technical requirements of the RFI, the RFI process, or any other provision.

1.8 AUTHORITY AND METHOD

OHA has authority and is using the Request for Information solicitation method, pursuant to ORS 279A.050.

SECTION 2: SCOPE OF WORK

2.1 SCOPE

The Oregon State Hospital is interested in receiving information from vendors to supply food and non-food items for resale to residents through the OSH Patient Market (Commissary). All non-food items must align with OSH safety standards, require an OSH Product Risk Assessment (PRA) and receive committee approval prior to being brought into the patient environment – please see Exhibit 2 for details. OSH procures approximately \$18,200 monthly of food and non-food product, 63% Salem and 37% Junction City, to meet the current demand of patient purchasing.

- a. **Food and Drink Items:** Food and drink items must be for individual consumption and must be in the original manufacturer's packaging and dated and delivered prior to their "best-by" date.
 - i. <u>Food product examples</u>: cup noodles, Ramen, Pop-Tarts, protein bars, nuts, meat sticks, cookies, chips, nacho cheese, individually wrapped candies, tuna snack packs, salmon snack packs, pulled pork/chicken snack pouches, Easy Mac, chili bowls, microwavable popcorn, fruit pies, peanut butter packets, snack cakes, individual packaged cereal, crackers, donuts, rice crispy treats, Honey Buns, oatmeal pies, Zebra cakes, etc.
 - ii. <u>Drink product examples</u>: soda (variety of flavors in 12 oz bottles), Gatorade, bottled water, sparkling water, sports drink packets, hot chocolate, teas, spiced cider, sugar free drink options. Aluminium cans are not permitted in the patient environment.
- b. <u>Non-Food Item examples</u>: bar soap, deodorant, body wash, shampoo, conditioner, hair products, toothbrushes, toothpaste, ChapStick, makeup (eyeliner, concealer, foundation, etc.), envelopes, crayons, folders, notebook paper, activity books, sketch pads, air fresheners, playing cards, wallet, Listerine Breath strips. Personal care items such as shampoo and loation must not contain a "pump" device to dispense product. Stationary items and activity books must not contain staples.
- c. <u>Electronic Item examples</u>: Bluetooth speakers, wireless headphones, Bluetooth transmitters, auxiliary cord (7"), USB charging cords, USB wall adaptors, handheld games, watches, wireless earbuds, foil shavers

2.1.2 Service Offerings:

- Delivery of products to Salem and Junction City OSH locations twice per month
- Ordering and product tracking system
- Collaborative effort to ensure compliance with all OSH safety regulations and Product Risk Assessments
- Provide a catalogue of a goods available for purchase, preferably in an electronic format.

 Maintain accurate record of sales, transportation & delivery. These records should be available for OSH inspection, examination and auditing to ensure accurate accounting of inventory.

2.2.1 Operational Capabilities:

- Food items must be individually packaged, in manufacturers original packaging for resale, and be dated & delivered prior to "best by" date
- Food & non-food items priced at, or lower, than local Salem and Junction City area retailers.

2.1.3 Experience:

Vendors with established, reliable supply chain to ensure dependable source of products for OSH patients. Prospective vendors should have experience in stocking commissary within institutional settings.

SECTION 3: SUBMISSION AND RESPONSE REQUIREMENTS

3.1 SUBMISSION REQUIREMENTS

OregonBuys Electronic Response. Respondent must submit its Response electronically through OregonBuys. Respondent must follow the procedures outlined in detailed instructions on how to submit a Response can be found at OregonBuys Vendor Formal Solicitation Response.

3.2 OWNERSHIP/PERMISSION TO USE MATERIALS

All Responses are public record and are subject to public inspection. Application of the Oregon Public Records Law will determine whether any information is actually exempt from disclosure.

All Responses submitted to this RFI become the property of Agency. By submitting a Response to this RFI, Respondent grants the State of Oregon a non-exclusive, perpetual, irrevocable, royalty-free license for the rights to copy, distribute, display, prepare derivative works of and transmit the Response solely for the purpose of reviewing the Response, or as otherwise needed to administer the RFI process, and to fulfill obligations under Oregon Public Records Law (ORS 192.410 through 192.505). Responses, including supporting materials, will not be returned to Respondent.

If Respondent believes any of its Response is exempt from disclosure under Oregon Public Records Law (ORS 192.311 through 192.478), Respondent shall complete and submit the Disclosure Exemption Affidavit (Attachment B) and Respondent also shall submit a fully redacted version of its Response, clearly identified as the redacted version.
